## **Details of Department of Employment Affairs and Social Protection Income of a person who is not party to a Grant Application**

### **Important notes**

This form should be completed where you (the applicant) have indicated to SUSI that there is a person in your household who is not party to your grant application but who is in receipt of a payment from the Department of Employment Affairs and Social Protection that may make you eligible for the special rate of grant.

Under Article 19(7)(b) of the Student Grant Scheme 2019 this person should be the spouse, civil partner, or cohabitant (not being your parent) of your parent (as named on your application) and must include an Adult Dependent Allowance in respect of your parent or a Child Dependent Allowance in respect of you.

To enable SUSI to take account of this payment SUSI will access the Department of Employment Affairs and Social Protection records for this person, this form is required to be completed and returned to SUSI. It must include details of this person (Name, Address, DOB, PPSN). Signed consent of this person is also required.

Please note that for this purpose ALL payments received by this person from the Department of Employment Affairs and Social Protection will be viewed. DEASP payments made to such a person are not reckonable as income for the purposes of your application, the fact that they receive such payments may make you eligible for the special rate of grant.

Details of payments that may make you eligible for the special rate of grant are listed in Schedule 2 of the Student Grant Scheme 2019.
